This contract is written and set up by "**Company name**" for dancer work in:

Hereafter named as the artist, that is based on issues discussed over a period of time. This contract will be signed by the parties involved (The club and the artist). And none of the parts can be re-released from this contract unless it is agreed between the parties.

All the parties are obligated to each other to solve any disagreements or misunderstanding that could come up during the time this contract is valid.

1. **Performance:** The artist is hired by "**Company name**" to perform (**optional**) different professional full nude striptease stage shows, with (**optional**) different costumes and music in "**Club Name**" every night. The minimum length of the show must be (**optional**) min. Totally up to (**optional**) stage shows a night. The artist can delegate duties, as mentioned in the previous sentence, to another person, given that the person has accepted the written terms laid down in this contract and given that "**Company name**" has given its prior consent.
2. **Dressing:** When the artist is not performing on stage, the dressing should be with clean elegant long or short dresses and high heel shoes, or Fantasy costumes.
3. **Accommodation:** Self catered appartement with: "**Description of the appartement**"
4. **Opening hours:** "**The clubs opening hours**" The artist is required to do her duties so that the club can be open at the communicated opening hours.
5. **Insurance:** Travel and health insurance has to be arranged by the artist herself.
6. **House rules and regulations:** The artist must read and sign the clubs house rues.

Conditions and salary

1. The artist gets (**optional**) % in commission for all private shows.
2. For wine and champagne the commission is (**optional**) %
3. The artist is guaranteed a minimum earning of (**optional**),-EUR if the artist has worked all opening days in a week.
4. Accommodation is paid and arranged by the Club (**optional**) Dancer
5. The artist has to pay for transport to and from the work and cleaning of the appartement. (**optional**)
6. The artist agrees to be classed as a NON residence Entertainer and be taxed after this rule. "**Company name**" is responsible of paying 15% in tax of all income. If the artists stay exceeds 183 days in the course of any 12 months period, or exceeds 270 days in the course of any 36 months period, the artist agrees to be classed as self employed and will be responsible of paying a higher tax rate. "**(Check this out with local rules)**"
7. The artist must have a bank account with IBAN number and SWIFT code, where all earnings can be paid.

Other agreements:

The artist cannot arrange dates with guests, and they are not allowed to leave the club with guests. The artist at all times is expected to behave in a professional manner that reflects a good name to themselves and the club.

Once this contract has been signed, both artist and management will agree to its terms and conditions. If a breach of this contract has been made against either side there shall be an settlement in favour of the wrong party.

The artist can only miss an evening's work due to illness or a very good reason that has been approved by the management.

8. Force majeure: In the event that the performance called for under this contract are rendered impossible by reasons of flood, earthquake, hurricane, war, civil strike, industrial dispute, epidemic, acts of God or law, order or decree, rule or regulation of any Government Authority or for any reason of a similar nature beyond the control of the contracting parties, it is agreed that this contract shall be null and void.
